# 1. Object of Agreement

Any dispute, controversy or claim arising out of or in relation to this contract including the validity, invalidity, breach or termination thereof, shall be finally resolved by arbitration in accordance with the international rules of international arbitration of the international chambers of commerce in force on the date when the notice of arbitration is submitted in accordance with these rules.

#### 9. Amendments and Supplements

No amendments to this contract shall be deemed valid and binding upon the parties unless made in writing and signed by the authorized representatives of each party. Agreement reached between signatories of the parties and exchanged via fax or email shall be considered as effective written agreement.

This contract is coming into full legal force after authorized representative of both contracting parties have signed each page.
